




売上高 Net sales



経常利益 Ordinary profit




親会社株主に帰属する当期純利益 Profit attributable to owners of parent




1株当たり純資産額 Net assets per share






売上高 Net sales




経常利益 Ordinary profit






1株当たり純資産額 Net assets per share
